SHIPPED SEMEN AGREEMENT

THIS AGREEMENT is to reserve shipped semen for the stallion **AKHADEMY⁺**/CAHR #0028561, standing at Todd Ehret Equine during the 20_____ Breeding Season.

- 1. FEES:** In addition to the agreed Breeding Fee paid to Todd Ehret on behalf of The Akhademy Partnership, the Mare Owner shall pay the following fees associated with Shipped Semen. These fees must be paid in full prior to Mare Owner receiving any shipments or breedings.
 - 1.1 Handling Fee.** The Handling Fee to Stallion shall be **One Hundred Dollars (\$100.00) Canadian Funds** per collection/shipment paid to Todd Ehret.
 - 1.2 Collection Fee:** Charged directly by the veterinarian.
 - 1.3 Shipping Expenses:** These charges will be billed directly, to the credit card account you provide below, by the service provider.
 - 1.4 Re-breeding Fee: Two Hundred Dollars (\$200) Canadian Funds** per mare, per year. For mares who did not produce a foal from a prior breeding paid to Todd Ehret.
- 2. PRE-BREEDING ARRANGEMENTS:** The Mare Owner must provide the following information prior to receiving any shipments.
 - 2.1** Copy of signed Breeding Agreement.
 - 2.2** This Shipped Semen Agreement signed by Mare Owner.
 - 2.3** Payment of all applicable Breeding Fees.
- 3. BREEDING ARRANGEMENTS:** The Mare Owner agrees to the following terms:
 - 3.1** The Mare Owner is to provide a twenty-four (24) hour advance notice to the breeding facility for shipment. All shipment requests must be cancelled by 10:00 a.m. the day of shipment. In the case of subsequent shipments, the shipping container, and any additional shipping fees (see above) must be received by the breeding facility before the next shipment is sent.
 - 3.2** If after three inseminated heat cycles your mare is NOT in foal, it may be required that your mare be transported to an approved breeding facility and/or further diagnostic tests be run before any additional shipments are sent.
 - 3.3** Every effort will be made to accommodate your mare's breeding timeframe; however, it is the Mare Owner's responsibility to keep in touch with the breeding facility so that your veterinarian and ours can get your mare in foal on a timely basis.
- 4. CREDIT CARD AUTHORIZATION:** Mare Owner authorizes The Akhademy Partnership and/or Todd Ehret and/or Veterinarian to charge the above referenced fees to the credit card account listed below.
